




## 44 + 44!

## Eighty-eight years of partnership

In 2020 it is forty-four years since the demise of Shell-Mex and B.P. Ltd a period of time which is, of course, equal to that of SMBP's period of trading. The SMBP 44 Association takes its name from the quantum of the SMBP years (44) and for our Club also to have lasted for the same period of time is certainly something to celebrate. (Technically the 44 Club dates from 1977 when a Committee was formed to launch it for the 9500 ex SMBP employees who were in the SMBP Pension Fund). The ex-Parent companies were supportive of the initiative and funded it.



The longevity of the 44 Club is attributable not just to the robust health of our members but also to a key decision taken early in the Club's life to welcome (as it was described) "any person who was regularly employed at some time between 1st January 1932 and 31st December 1975 by any company in the SMBP Group...provided he or she is receiving a pension from any fund associated with BP or Shell or SMBP." So those of us who went to Shell and BP on Brand Separation and had careers with the Parent companies became eligible to 44 Club membership - the vast majority (all?) of our current 2500 members are in this category.

#### SHELL-MEX HOUSE

#### COMMANDING BUILDING ON HOTEL CECIL SITE

The site of the old Hotel Cocil, the last vestiges of which disappeared at Easter, is now undergoing rapid transformation. The erection on the site of Shell-Mex House, the future headquarters of Shell-Mex, Limited, has reached a point at which 400 tons of steelwork are being raised each week, some 1,600 tons being already in position. It is hoped to finish the whole building by December of next year. When that stage is attained the Victoria Embankment will be dominated by one of the largest, and certainly the most commanding, commercial buildings in London, the cost of which is estimated at £1,500,000.

So let's go back to the formation of SMBP in 1932. The press cutting from The Times on the front cover of this edition of the magazine tells the bare facts about the coming together of BP and Shell-Mex (Royal Dutch Shell). Shell-Mex was already a partnership (since 1921) between Shell and Anglo-Mexican (Eagle). The marketing of oil products in the UK had been controlled since 1928 by what was known as a 'Pool Association' - this also included the American companies Standard Oil New Jersey, Gulf and Standard Oil Indiana. It was what we today would call a 'restrictive trade practice' and essentially allocated volume by agreement rather than it being a consequence of competition. But the merger of Shell and BP's operations went a step further though up to WW2 SMBP had to stick to the Pool Association arrangements. SMBP from the start was a cost reduction exercise driven by the very difficult economic circumstances of the times. The Wall Street crash on 1929 had dire consequences around the world of course though the creation of SMBP (we all might argue) was a positive among all the negatives! Although austerity was the mark of the times we can only marvel at the vision of the founders of Shell-Mex and B.P. Limited – not least the commissioning of Shell-Mex House which was formally 'opened' in January 1932 and occupied a year later. Shell-Mex House broke new ground for offices



in London both in respect of its scale and architectural design. It was a statement of intent of a potentially very confident company. It is interesting to note that the first press report about Shell-Mex House predated by six months the announcement of the formation of SMBP and in that report it is described as the 'Future headquarters of Shell-Mex Limited'. The plans for the creation of SMBP were discussed in great secrecy but the scale of Shell-Mex House is such that a decision about the formation of SMBP clearly pre-dated the decision about its construction.

The company initially had 15,000 staff though this fell to 12,400 by 1939. With the staff reductions came also rationalisation of facilities as depots and offices merged and closed. The Petroleum Board which was formed for the War (and beyond) was dominated by SMBP people and, as John Higdon put it in his History of SMBP, "...SMBP had carved a position or pre-eminence in the domestic oil industry which was to last its life time to the chagrin of its major competitors. Also to the surprise of its parents!"



By the time that growth took off in the post-war years and also as competition returned, rather slowly, in the early 1950s when branded marketing recommenced SMBP was very much in pole position to benefit, and we did! SMBP created the modern downstream oil industry in the UK and there was no part of the British economy that we didn't supply and in many cases expand. That we were in the right place at the right time is true but that shouldn't underrate the innovation. Coal to Oil conversion; sophisticated lubricants; the Domestic Fuel market; Aviation Fuels; Solus petrol stations, Self-serve; packed LPG; Bitumen and virtually every other oil-related initiative of the 1950s and 1960s was pioneered by SMBP.

#### So why separate?

It seems that the first rumblings of the possibility of Brand Separation took place around the mid-1960s. There was, you might recall, a Labour Government at the time and intuitively this suggests that concerns about a referral to the Monopolies Commission may have been in mind. SMBP was certainly a monopoly in many areas by a strict application of what a monopoly is. However I can find no evidence that SMBP was in Harold Wilson's sights (though there had been an investigation into 'Solus'). Much more likely is that post McKinsey in 1964/65 there was a trend towards greater branded marketing - albeit under the SMBP umbrella. In Shell tentative discussions took place and various studies occurred – mostly in great secrecy. By 1970 meetings between Shell and BP commenced in earnest and by the end of the year a recommendation to separate was put together. The Board of SMBP was 'consulted and consented'. This report of what happened does not, however, explain why it happened! SMBP was undoubtedly a profitable enterprise fulfilling the Boston Consulting Group's criterion of a 'Star' operating in (mostly) High Growth markets and with a high market share in them. Don't rock the boat you'd think.

Tony Page, a member of the Brand Separation team, wrote some twenty years ago that in his very personal view the drivers of Brand Separation were not 'cerebral' but gut reaction – that there was an '...instinctive dislike by each parent company of the other's philosophy'. Readers will have their own views about this – it rings true to this old boy!

#### After the Ball was over

That Shell-Mex and B.P. was much more than 'just' a business is surely self-evident even from the above very brief sketch of its history. It was quintessentially British in construct and operation and it was very rare for assignments from or to Shell or BP to take place and there was hardly ever a non-British national in any key job. Post Brand Separation this changed and many of us were lucky enough to work abroad once we were in either Shell or BP. In the years since the mid-1970s both Shell and BP have gradually centralised their global decision making. The freedom to operate that we had in SMBP was matched later in the operating companies of Shell and BP but by the time of the new Millennium this had changed and the OpCo became a much less autonomous and independent unit. The construct of Shell-Mex and B.P. would certainly not work in the new world of downstream oil!

#### And so to the 44 Club...

It was a Ball, but it was over. But on 1st January 1976 the SMBP Group disappeared, except for the SMBP Pension Fund which had 9500 members. Continuity was assured for these pensioners despite the fact that the Fund was one of the first 'Heritage' Funds – it would never have any new members. The Board of the Fund was made up of senior executives from Shell UK and BP Oil and John Greenborough was its Chairman. But what about providing a Pensioners Association for these

#### A PART OF OUR HISTORY

SMBP Pensioners? That's where the idea of the 44 Club came in. It's worth recalling its original 'Objectives' (right):

I think that we can say that these objects have been met and continue to be though (c) faded somewhat when the SMBP Fund was absorbed into the Shell Contributory Pension Fund.

#### ... and the Benevolence Association

In 1983 a major step forward was made when the 'Shell-Mex and BP Pensioners Benevolence Association' was formed and although this was a separate entity from the 44 Club and the Pension fund it was closely linked to them. The photo shows the Association's first Chairman Tom King and the then Finance Director of Shell U.K. John Bonds

Let me now, with a bit of a smile, say what was originally said about the 44 Club back in 1977:

"... actuarially it will take twenty-two years to reduce the number of people in the SMBP fund to half what it is now. We therefore concluded that our Association could enjoy a useful existence for ten to fifteen years at least and was therefore well worth proceeding with"

A. To keep the family spirit alive amongst the retired staff of the SMBP Group.


- B. To collect and circulate interesting news about members and former staff of the SMBP Group.
- C. To provide, as may at any time be required, a means of representing pensioners of the SMBP Group on pension and associated matters.
- D. To facilitate maintenance of the friendships existing between members
- E. To co-operate, where possible and desirable, with pension liaison officers and other organisers in the promotion of social events for members.
- F. To collaborate, where mutually beneficial, with other similar organisations in the oil industry
- G. To do all such other things as may from time to time be necessary, incidental or conducive to the attainment of these aims.

Well forty-four years later here we still are! Obviously the decision taken early in the Club's life to invite those ex SMBP employees who went to Shell or BP on Brand Separation but who then retired with a Shell or BP Pension to join the Club was crucial. The Club now has just under 2500 members - a fall of course from the 3230 of five years ago, but still respectable. In 1983, eight years into the post SMBP life, the Club had 5250 members this was to fluctuate over the years. The Club is less active than it once was, there are fewer Branches and fewer events. The potential is there to do more but that requires volunteers and none of us is any younger. But there is no reason for pessimism. The magazine is well-received and there is enormous goodwill for it as well as for the Branches.

We have been fortunate over the years in those who have given us leadership - especially the administrators from Geoffrey Baines via Charles Madge to Colin Hill and the Chairmen from Geoffrey Sentence to Rick Westley. And I am proud to be in the line of 44 Club News editors from John Higdon, via Barrie Dugdale and Mike McMonagle - eccentrics all of us as it should be! From the start the Club News had contributions from members and I am pleased that this tradition is very much maintained today. Also from the start the newsletter/magazine did not take itself too seriously and there has been a

consistent lightness of tone. Even the Obituaries remember the happy times rather than indulging too much in mourning.

When the SMBP 44 Association was formed in 1977/8 there were still one or two ex-employees around who had joined SMBP on its foundation in 1932. Today we are all veterans of the post war era of the Company – a golden age during which the Shell, BP, Power, National Benzole and other Group brands genuinely led the Oil industry in the UK. The Club and this magazine nostalgically remember those days and the achievements. But above all we remember the friends we made and the good times we had. **PSB**

#### The Shell Heritage Art Collection

An interesting side story to the Art collection is that, when I moved over to Shell from Power at the end of1963, by a series of occurrences it is not necessary to go into, within a very short time I was put in charge of the section. One of the first things to happen was that I was contacted by Estates to say that there was a load of rubbish in the cellars which they thought was ours and would I make some effort to get rid of it since they needed the space. I went down and found bays full of Shell posters, rolled in bundles.

I applied for space to store them but without much luck - nobody was interested. I continued to fight for space with much the same result when, by a happy coincidence, a poster, - Journalists prefer Shell came up for sale in a West London Gallery. It fetched £1,500 (this is 1964, remember) and rated a story in a daily paper. Armed with this I pointed out that we had over 20 of that poster and about 6,000-7,000 others. I, immediately, was allocated a room Dexion racking, plastic sheaves etc. and we were able to preserve them.

When, in the late sixties, I was transferred to Industrial Advertising, we used to buy in the Retail calendar.

Then, for some reason, they changed direction in their design e.g. nudes with furry animals, and Rea Leach and I decided that was not for us. We returned to the Shell tradition of nature and the use of artists, selecting a well-known artist one year and then a new artist the following year, using a name to write the accompanying copy e.g. when I found Audrey North, then unknown, I got Phil Drabble to write the copy. We used some good artists, Peter Newcombe, Keith Shackleton etc. and, when I retired, we were printing over 80,000 copies a year and they were being sold in Shell garages!

#### The Studio

The Studio was part of the 'S.P. & A Department' which occupied the whole of the 8th floor Clock Tower corridor, with the Studio at the Savoy end, until after McKinsey. I arrived to work for Bill Sands in the new section set up for Domestic Heating Advertising in April 1959. Within my first hour I was taken along to the Studio, which had a separate area for displays. There I was introduced to an Account Executive and an Art Director from S.H. Bensons Advertising Agency. Heady stuff for a young man fresh from Aylesford Terminal!

I helped them to pin up the designs for the Mrs 1970 campaign - mockups of consumer leaflets, designs for Appointed Merchant and Installer signs, van painting guides etc. etc. This was all for a presentation to Management, I'm not sure if it was to Departmental or to the Board.

At that time the Studio carried out varied design work. Exhibitions were a prime advertising tool at that time - Agricultural Shows, Smithfield and later the Ideal Home Exhibition. The plans for these were all done by the Advertising Studio. They also worked on smaller, sometimes personal, items. When I got married in 1960, a colleague kindly collected good luck signatures and these were bound into a folder designed by Al Hotham, who was one of the artists. I still have it somewhere but don't climb into the loft as often these days!

They also had the best Christmas parties and obviously the best decorations.

I was the office junior from 1949 -1954. The Studio staff included Tom Gentleman, Tom Gorringe, Tom Palmer, Len Crawford, Blythe Ellis and Chalky White. Palmer and Crawford used to sub their salaries by sending cartoons to Punch, Reveille etc., having tested them on me first. We saw the reintroduction of branded petrols and the launch of Shell X 100 motor oil. In house work by Studio staff peaked when the Mithras Temple was discovered under Cannon St we had adverts in the lunchtime papers ! Aviation Ads began with series like 'From Vimy to Viscount'. Introduction of ADs occurred with a need to promote Agricultural products (Tractor Oil Universal etc). SMBP had to give up our trademarks for DERV and TVO because of common usage! Production of Lorry Bills continued and a Schools edition of posters were issued - 'Flowers of the Countryside'. There were Shell Valentine cards and the return of

Motor racing sponsorship established a specialist section. There was also the 'Film Service' under the direction of Geoffrey de Gruchy Barkas who had been a leader of the art of camouflage during the war. The maintenance of historic artwork and records was one of my prime jobs.

When I joined the SPA division of SMBP in December, 1963, Tom Gorringe was, perhaps, past his glorious best but I have fond memories of him scuttling - Tom never walked - along the corridor. He would come in each morning from his cottage in Essex, always enthusiastic about something, whether it was the project in hand or his beloved amateur dramatics.

When I, a little later, took over the Studio the old guard had gone but it remained an area of controlled anarchy. Now it was the domain of younger people, mostly from The Hackney School of Art. I am afraid that names now elude me but one or two stand out. Bob Billington, who spent his spare time developing a new type-face which, eventually, was included in the official list, and Kate. Kate came in for interview with Stanley Simmons (of blessed memory) and myself and, after ten minutes of excruciatingly hard work to get a coherent word from her, we bit the bullet and asked to see her portfolio. We almost recoiled from the enthusiastic, ebullient girl who emerged – and her portfolio was superb. No brainer, and she was a great asset whilst she was with us.

Retail had a habit then of going out to designers for ideas for, say, can design, ignoring the studio. I insisted that their designs were put into the test mix and, to our pleasure and their chagrin, more than once the studio design came out top. And all of this was in the old 'cut and paste,' literally, days. I wonder how many people remember 'lorem ipsum dolor...'

I used to take the four of them out to lunch at Christmas and I think they wanted to test the 'old man'. We ran the gamut of Indonesian, Thai, Japanese etc. until I wondered what had happened to my taste buds! But they were great days, a talented, hard-working team of which I was proud to be a part.

#### **Domestic Heating Centre**

I did enjoy Cliff Quarrell's letter about the DHC at Fulham and the late Ken Tuvey. I did nearly ten years in the Domestic Heating market in several roles and recall the many courses I attended there to learn about central heating systems and oil fired boilers. We were usually accommodated in second rate hotels in the Cromwell Rd area of London though later on, after some complaints the standard of hotels improved somewhat! We used to have some good evenings out, eating at restaurants, such as the Contented Sole in Kensington where the fish was outstanding, and a pianist playing all the old London songs. Some chaps went to Soho to see the sights!

I worked in the Norwich Domestic Area under a lovely manager, Jack Farnell, an absolute gentleman and became a Domestic Markets Representative (Developer) in Suffolk. My job was to call on builders etc. with a view to installing oil fired heating in new houses. Oil was a cheaper fuel than gas at the time but the oil fired boilers were usually more expensive which did not appeal to developers. There was also two DMR (Householder) Reps who signed up the owner when they had their own tank. The idea of a central tank supplying an estate of houses was already under way (Central Storage). This new set up started on 1 November 1965, under Regional manager Bob Breese.

Ken Tuvey was not on the staff then but joined us in 1966 as a Technical Service Representative - he was a very forthright chap, who definitely called a spade a spade, and was such an expert on heating systems and their foibles. In 1967 he installed a Husqvarna boiler for me in my old cottage. He would do anything for most people. I had thirteen years with SMBP, 10.5 with Shell UK, and 13.5 with Shell International as a Pensioner Liaison Representative. And 26 years ongoing as Secretary of King's Lynn 44 Club Branch.


